**ARTICLES OF ORGANIZATION  
OF

The undersigned authorized agent of the initial Member of the above limited liability company hereby certifies that the sole Member, for the purpose of forming a limited liability company under the laws of the State of Florida, hereby executes the following Articles to provide for the formation, rights, privileges, and immunities of a limited liability company for profit. **ARTICLE I  
NAME**


