ADMISSION OF ADDITIONAL MEMBERS**

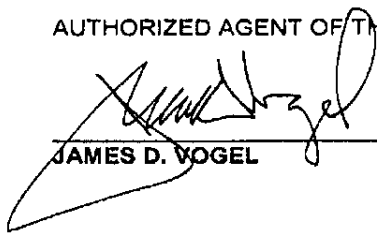
Upon approval as set forth in the Operating Agreement of the company, the company is authorized to issue additional Units and to admit Additional Members to the Company.

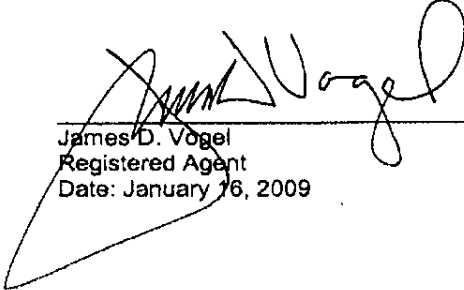
