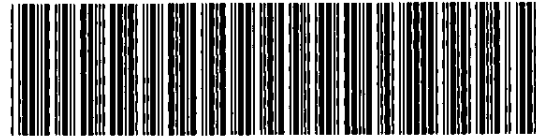

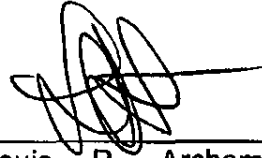
ARTICLE VI
