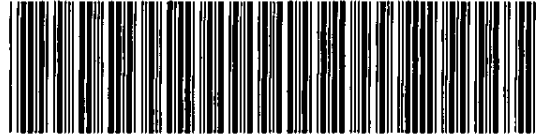



ARTICLE IV




