The name of the limited liability company is WHITE LOTUS #2, LLC.

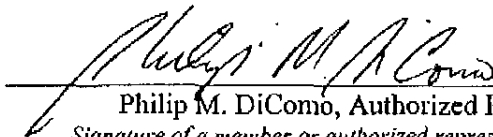

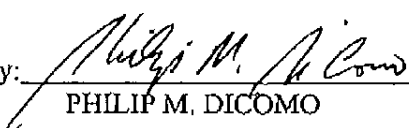
