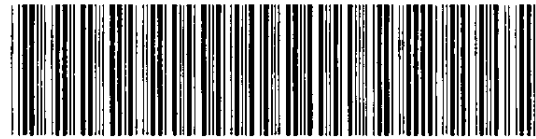

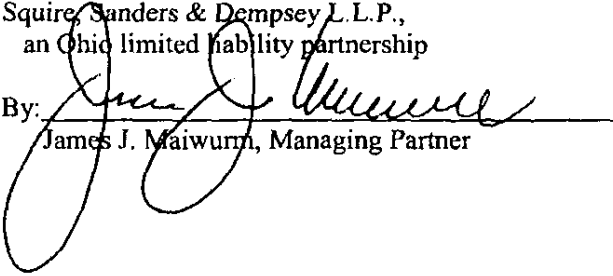
1. The name of the limited liability company is SHD GLOBAL LLC.
