## ARTICLES OF ORGANIZATION OF ICC II, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

1. Name. The name of this limited liability company is **ICC II, LLC**.
2. Duration. The latest date upon which the limited liability company is to dissolve is January 1, 2059.
3. Mailing Address and Street Address. The Company's mailing and street address is: **150 Alhambra Circle, Suite 800, Coral Gables, Florida 33134**.

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the remaining members may, by unanimous written agreement, continue the business of the Company.


