**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Modular Technology Corp. Its principal office address is 100 SE Second Street, Suite 4000, Miami, Florida 33131, Attention: Robert B. Macaulay, and its mailing address is JBC SJO No. 6061, Box 025240, Miami, Florida 33102.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 10,000 shares of common stock, having a par value of \$.01 per share.

**ARTICLE V - INITIAL
REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this Corporation shall be 4221 W.
