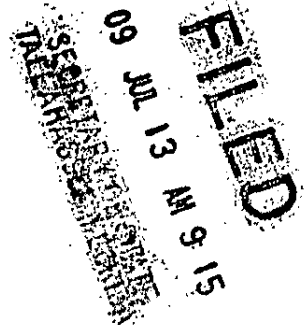
The general purpose for which this Company is organized is to engage in any lawful business for which limited liability companies may be organized under the Act.

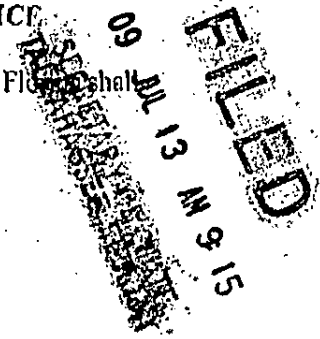


