**AMENDMENT TO ARTICLES OF INCORPORATION
OF
WOOL WHOLESALE PLUMBING SUPPLY, INC.**


Pursuant to Florida Statutes Section 607.1006, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

1. ARTICLE III is hereby amended to read as follows:

The total number of shares the Corporation is authorized to issue is Ten Thousand (10,000) shares of which One Thousand (1,000) shall be voting common stock and Nine Thousand (9,000) shall be non-voting common stock. Each share of the Corporation's stock shall have no par value per share. Voting Common Stock shall have the same rights and preferences as the holders of non-voting Common Stock, except that the holders of the non-voting Common Stock shall have no voting rights whatsoever. All of said stock shall be payable in cash, property (real or personal) or labor or services in lieu thereof, at a just valuation to be fixed by the Board of Directors.

2. The Amendment was unanimously adopted by the directors and shareholders of the Corporation on July 31 2009.
3. Except as hereby amended, the existing Articles of Incorporation of the Corporation shall remain in full force and effect.
