The undersigned, a natural person competent to contract, hereby organize and form a limited liability company under and pursuant to Chapter 608, Florida Statutes, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. I further declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE 1 - NAME

1.1 The name of the limited liability company shall be ALPHA MEDICAL INNOVATIONS, L.L.C.

ARTICLE 5 - RESTRICTIONS ON MEMBERSHIP

- 5.1 Members shall have the right to admit new members, but only by unanimous consent of all members. Contributions required of new members shall be determined as of the time of admission to the limited liability company by unanimous consent of its members.
- 5.2 A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all the members.

ARTICLE 6 - MEMBERS' RIGHTS TO CONTINUE BUSINESS

6.2 Upon the death, retirement, resignation, expulsion, bankruptcy, dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business upon unanimous consent of any such remaining members.

ARTICLE 7 - CAPITAL CONTRIBUTIONS

- (G) The several clauses contained in this statement of the general nature of the business or businesses to be transacted shall be construed as both purposes and powers of this limited liability company, and statements contained in each clause shall, except as otherwise expressed, be in no way limited or restricted by reference to or inference from the terms of any other clause.
