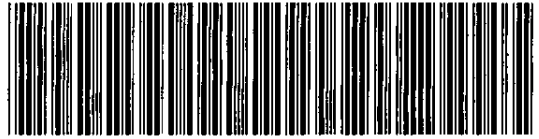



ONE: The name and address of this principal corporation is Rising Angels Daycare and Resource Center, Inc. at 104 Carlisle Ct, Kissimmee, FL 34758, in Osceola County. The Corporation is organized pursuant to the FLORIDA Non-profit Corporation Code.


