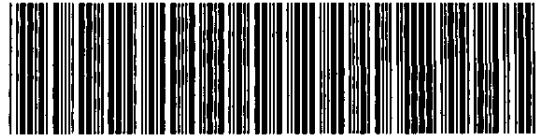

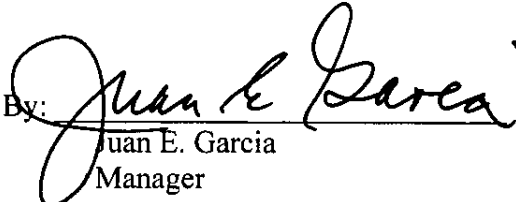

7. There are no suits pending against the Company in any court.

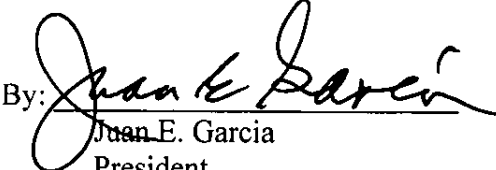
