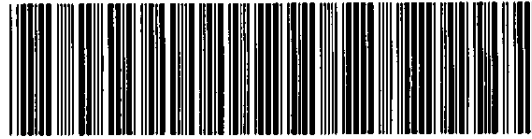

The Company is be managed by its member(s) and the name of the managing member is Carlo Maria Paoletta.

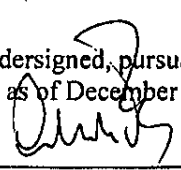
ARTICLE V - Purpose:
