CERTIFICATE OF THIRD AMENDMENT TO ARTICLES OF INCORPORATION OF PINE ISLAND RIDGE COUNTRY CLUB, INC.

(A Florida not-for-profit corporation)
Pursuant to Section 617.1002 of the
Florida Not-For-Profit Corporation Act

We, Arthur Smith and Renee Rosenberg, as President and Secretary, respectively of PINE ISLAND RIDGE COUNTRY CLUB, INC., a Florida not-for-profit corporation ("Association"), thereby certify under the seal of the Association as follows:

- 1. The Association was originally incorporated on March 22, 1973, Document Number 725882, under Chapter 617 of the laws of the State of Florida.
- 2. The Articles of Incorporation ("Articles") were amended by that certain Amendment to the Articles of incorporation of Pine Island Ridge Country Club, Inc. dated April 18, 1980 and thereafter further amended by that certain Amendment to the Articles of Incorporation of Pine Island Ridge Country Club, Inc. dated June 19, 1992.
- 3. The Association wishes to amend the Articles in accordance with the requirements of Article XIII of the Articles which provides that the Articles may be amended by a resolution approving a proposed amendment adopted by a majority of the Board of Governors ("Board") certified to by the President and attested by the Secretary of the Association. In accordance with Article XIII of the Articles no members are entitled to vote on the amendment.
- 4. A duly called meeting of the Board was held on November 24, 2009 at which meeting a majority of the Board voted to amend Paragraph 6, Article X of the Articles as hereinafter described and a resolution was adopted by the Board approving same.

NOW, THEREFORE, the Articles are hereby amended as follows:

1. The last sentence of Paragraph 6, Article X of the Articles is hereby deleted in its entirety and replaced with the following:

"If a Governor is absent from three (3) regularly scheduled Board of Governors meetings during his or her term of office, the Governor shall be considered to have vacated his or her position as a Governor and shall be automatically removed from the Board of Governors. Further, the Governor removed shall not be eligible to re-serve as a Governor for a period of one (1) year from the date of his or her removal."
