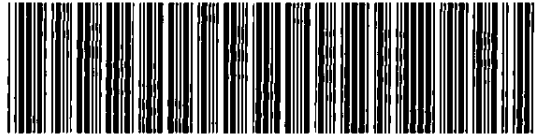

ARTICLES OF INCORPORATION  
OF  
FELLOWSHIP OF PALENCIA, INC.

The undersigned incorporator of these Articles of Incorporation, a natural person competent to contract, hereby presents these Articles for the formation of a not for profit corporation under the Not For Profit Corporation Act and other laws of the State of Florida.

ARTICLE I

The name of the Corporation is Fellowship of Palencia, Inc.

ARTICLE II

The principal office of the Corporation initially will be at 672 Hannah Park Lane, St. Augustine, Florida 32095. The principal office may be moved to any address in the State of Florida that the Board of Directors may choose.

ARTICLE III

The Corporation is formed for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of the United States. These purposes, may include the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code).

ARTICLE IV

No part of the net earnings of the Corporation will inure to the benefit of or be distributed to its members, trustees, directors, officers or other private persons, except that the Corporation will be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the Corporation will be the carrying on of propaganda, or otherwise attempting to influence legislation. And the

Corporation will not participate in, or intervene in (including the publishing or distributing of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

The Corporation will have the power to do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects for the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendments, and either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes and objects of this Corporation.

Notwithstanding any other provision of these Articles, the Corporation will not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future federal tax code).

#### ARTICLE V

The initial number of directors of the Corporation will be three (3). The number of directors may be changed by bylaws adopted by the members. The number of directors will never be less than three (3). The method of election of directors will be stated in the bylaws of the Corporation. The initial Directors will be.

#### ARTICLE IX

Upon dissolution of the Corporation its assets will be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The designated recipient is Clara White Mission. And if that organization is no longer in existence or an eligible organization then the directors may designate another eligible organization or the assets will be distributed for a public purpose to the United States, to the State of Florida, or a local government.

#### ARTICLE X

This Corporation will exist perpetually.

#### ARTICLE XI

No contract or other transaction between this Corporation and any other corporation will be affected by the fact that any director of this Corporation is interested in or is a director or officer of such other corporation. Every person who may become a director of the Corporation is hereby relieved from any liability that might otherwise exist from contracting with this Corporation for the benefit of the director, or any firm, association, or corporation in which the director may be interested in any way. The foregoing is predicated upon prior disclosure of the interest of the interested director.

#### ARTICLE XII

This Corporation will have the power to enter into, for the benefit of its employees, one or more of the following: a pension plan, a thrift or savings plan, health insurance plan, or other retirement plan.

#### ARTICLE XIII


The Corporation will indemnify any and all persons who may serve or who have served at any time as directors or officers, or who at the request of the Board of Directors of the Corporation may serve or at any time have served as directors or officers of another corporation in which the Corporation at the time owned or may own shares of stock or of which it was or may be a creditor, and against any and all expenses, including amounts paid upon judgments, counsel fees, and amounts paid in settlement (before or after suit is commenced), actually and necessarily incurred by the person(s) in connection with the defense or settlement of any claim, action, suit, or proceeding in which they, or any of them, are made a party, or parties, or that may be asserted against them or any of them, by reason of being or having been directors or officers of the Corporation, or of an other

corporation except in relation to matters as to which any director or officer or former director or officer or person will be adjudged in any action, suit, or proceeding to be liable by his or her own gross negligence or misconduct in the performance of his or her duty. Indemnification will be in addition to any other rights to which those indemnified may be entitled under any law, bylaw, agreement, vote of Members, or otherwise, and the Corporation will indemnify any officer or director, or any former officer or director to the fullest extent permitted by law.

#### ARTICLE XIV

These Articles of Incorporation may be amended in any manner provided by the laws of the State of Florida and in the bylaws.
