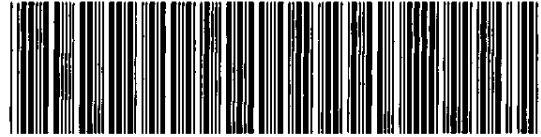

ARTICLES OF ORGANIZATION

OF

BARON GUARANTY, LLC

ARTICLE I - NAME

The name of the Florida limited liability company shall be BARON GUARANTY, LLC.

ARTICLE II - DURATION
