#### AMENDED AND RESTATED ARTICLES OF INCORPORATION

OF

#### 21st Century Centennial Insurance Company

In compliance with the requirements of Section 1915 of the Business Corporation Law of 1988 (15 Pa. C. S. §1915) and Section 21204 of the GAA Amendments Act of 1990 (15 P.S. §21204), 21<sup>st</sup> Century Centennial Insurance Company desires to restate in their entirety its original Articles of Incorporation and all amendments thereto, and, thereby, cause these Amended and Restated Articles of incorporation to supersede such original Articles of Incorporation and all amendments thereto.

#### ARTICLE'I.

The name of this corporation shall be 21st Century Contemnial Insurance Company.

#### ARTICLE IL

- (a) The address of the conporation's registered office in the Commonwealth of Pennsylvania is c/o Corporation Service Company. Dauphin County.
- (b) The corporation's principal place of business shall be located at 21st. Contury Plaza, 3 Beaver Valley Road, Wilmington, DH 19803.

#### ARTICLE III.

The corporation was incorporated on July 7, 1977 under the Business Corporation Law of 1988, as amended and the Insurance Company Act of May 17, 1921, as amended, relating to the incorporation and regulation of insurance companies.

If shares are issued for other than money, the value of the consideration shall be determined by or. In a manner provided by the Board of Directors. Consideration for shares shall be provided or paid to the corporation or as ordered by the Board of Directors.

#### ARTICLE IX.

To the fullest extent permitted by Pennsylvania law, as now in effect and as amended from time to time: (a) a director of the corporation shall not be personally liable for any monetary damages for any action taken or any failure to take any action and (b) the corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending or completed action, suit, or proceeding, whether civil, criminal, administrative or investigative (including, but not limited to, any action by or in the right of the corporation), by reason of the fact that he or she is or was a director, officer or employee of the corporation or serves or served any other enterprise at the request of the corporation against expenses (including attorneys' fees), Judgments, fines and amounts paid in acttlement, actually and reasonably incurred by such person in connection with such threatened, pending or completed action, suit or proceeding.
