Pursuant to the provisions of Section 617.1001 and Section 617.1002 of the Florida Statutes,
the undersigned Corporation adopts the following Articles of Amendment to its Articles of
Incorporation:

1. The name of the Corporation is **Big Brothers/Big Sisters of Greater Miami, Inc.**
2. The following is the Amendment to the Articles of Incorporation of the Corporation
which has been adopted, to-wit:

"Article I, which relates to the name of the Corporation, is amended to read as
follows:

'ARTICLE I


The name of this corporation shall be:
