The name of the limited liability company is SINGER ISLAND 704B, LLC (the "Company").

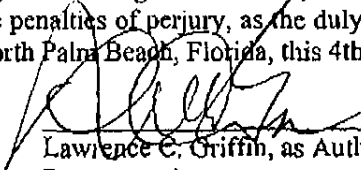
ARTICLE II - ADDRESS

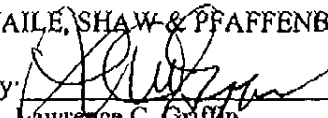
