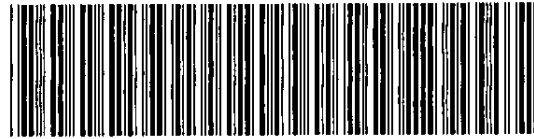

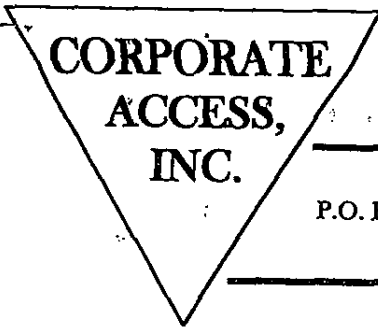

NAME**

DURATION**

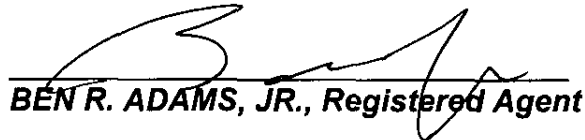

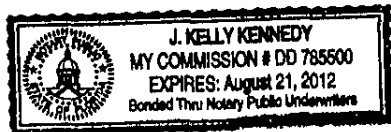
