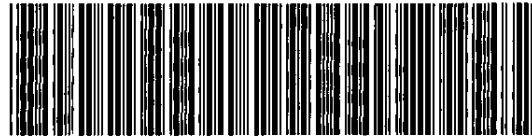



ARTICLES OF ORGANIZATION
of
ARKANSAS COTTON FARM, LLC
A Florida Limited Liability Company

ARTICLE 1
NAME

The name of this limited liability company is Arkansas Cotton Farm, LLC.


