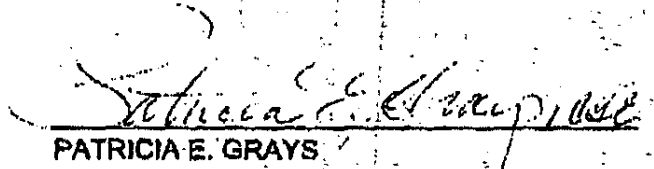

ARTICLES OF AMENDMENT
of
ANTI-DEFAMATION LEAGUE OF B'NAI B'RITH

TO: Department of Consumer and Regulatory Affairs

Pursuant to the provisions of the District of Columbia Non-profit Corporation Act, the undersigned adopts the following Articles of Amendment to its Election to Accept:

FIRST: The name of the corporation is: Anti-Defamation League of B'nai B'rith.

SECOND: The following amendment of the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the District of Columbia Non-profit Corporation Act:

1. Article FIRST, is hereby amended to read as follows:

FIRST: The name of the Corporation is "Anti-Defamation League."

2. Article FOURTH, is hereby amended to read as follows:

FOURTH: The Corporation has no members and shall not issue any capital stock.

3. Article FIFTH, is hereby amended to read as follows:

FIFTH: The affairs of this Corporation shall be administered by a board of directors who shall be known as the "Anti-Defamation League National Commission."

THIRD: The amendment was adopted in the following manner:

The amendment was adopted at a meeting of the Board of Directors held on October 31, 2009 and received the vote of a majority of the Directors in office, there being no members having voting rights in respect thereof.
