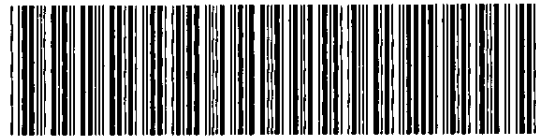

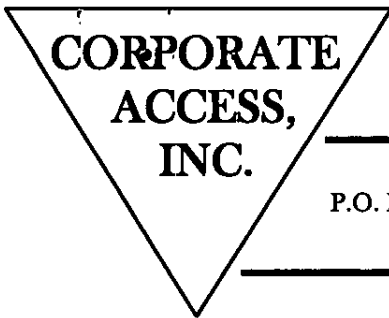

**ARTICLES OF ORGANIZATION
OF

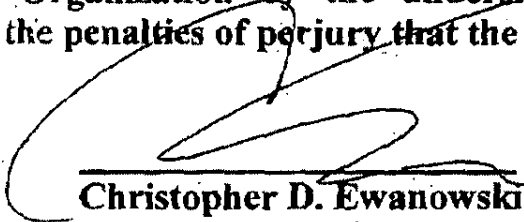
Article 5. - Management

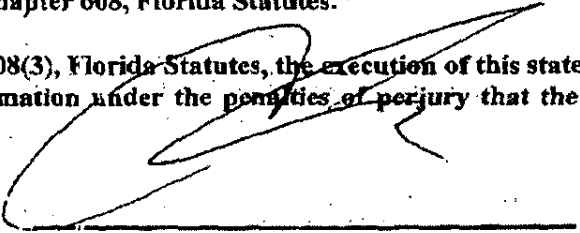
