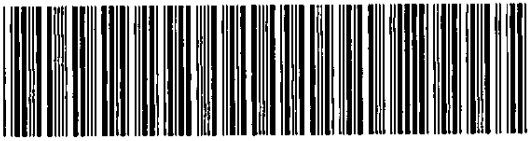

**Articles of Incorporation  
In Compliance with Chapter 617, F.S., (Not for Profit)**

**National Association for Relationship and Marriage Education,  
"Building Strong Marriages, Fathers, and Families"**

The undersigned, acting as the incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, the Florida Not For Profit Corporation Act. adopt the following Articles of Incorporation for such corporation:

**Article I - NAME**

The name of the corporation shall be: **National Association for Relationship and Marriage Education, Inc.**

**Article II - PRINCIPAL OFFICE**

The principle street address and mailing address of this corporation is 2252 Killearn Center Blvd, Suite 100, Tallahassee, Florida, 32309.

**Article III - PURPOSE**

The purpose for which the corporation is organized includes, but is not limited to: fostering education for healthy marriages, responsible fathers, and strong families in America. The corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law).

**Article IV - MANNER OF ELECTION**

The Board of Directors shall consist of men and women who fully support the Organizational Charter. The authorized number of the Board of Directors of this corporation shall be no less than three. Each Director shall serve for one term of not more than five (5) years. A Director may serve one (1) additional term of not more than five (5) years by majority re-election by the Board of Directors. No Board Member shall serve more than two full terms in succession.

A vacancy in any office, whether due to death, resignation, removal, disqualification, or otherwise, may be filled by the Board of Directors. Any person appointed to fill a vacancy on the Board of Directors shall hold office for the un-expired term of his predecessor in office, subject to the power of removal contained herein.

The Board of Directors may remove any officer of the Corporation when, in its judgment, the interests of the Corporation would be thereby best served. Any such removal shall be without prejudice to the contract rights, if any, of the officer so removed. Any Director may be removed, with or without cause, by the vote of two thirds of the members of the Board of Directors at a special meeting called for that purpose.

### **Article VIII - POWERS**

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, except that the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

### **Article IX - MANAGEMENT OF CORPORATE AFFAIRS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors. The number of directors of the corporation shall be not less than three (3) and may be such number greater than three (3) as may, from time to time, be voted upon by the Board of Directors.

### **Article X - DEDICATION OF ASSETS**

No part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the tax-exempt purposes of the corporation set forth in Article 3.

### **Article XI - DISTRIBUTION OF ASSETS**

The period of the duration of the corporation is perpetual unless dissolved according to law. Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for Charitable, religious, or educational purposes as shall at the time qualify as an organization exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine.

### **Article XII - PROHIBITED TRANSACTIONS**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

**Article XIII - NONDISCRIMINATORY POLICY**

The corporation shall have a racially nondiscriminatory policy and therefore shall not discriminate against employees, participants, and others on the basis of race, color, or national or ethnic origin.
