
ARTICLE IX

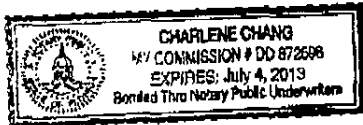


