

## **ARTICLE I**

The name of the corporation is **SEWING FOR TEENS, INC.** 

### **ARTICLE II**

The street address of the initial registered office of this corporation is 5745 Benedict Road, Jacksonville Florida 32209 and the name of the initial registered agent at that address is Felicia A.
