

Articles of Organization of the Sand Acorn LLC



A Florida Limited Liability Company

Section 1.01 Introduction and Preliminary Statements

Additional contributions to the Company shall be made at such times and in such amounts as may be provided in the Operating Agreement.

Section 1.10 Additional Members

The Company shall have the right to admit additional Members to the Company in accordance with the terms and conditions of the Company's Operating Agreement.
