- A. The name of the limited liability company is Brandon Honda, LLC (the "Company").
- B. The Articles of Organization of the Company were filed with the Florida Secretary of State on October 7, 2010 and assigned document number L10000105127.

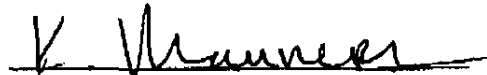
