ARTICLES OF ORGANIZATION

of

206 LAVISTA CIRCLE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME AND ADDRESS

The name of the limited liability company shall be 206 LaVista Circle, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 8842 McKenna Drive, Jacksonville, Florida 32226.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VI**MANAGER**


