I have prepared and submit with this letter an amendment to the Articles of Organization changing the name.

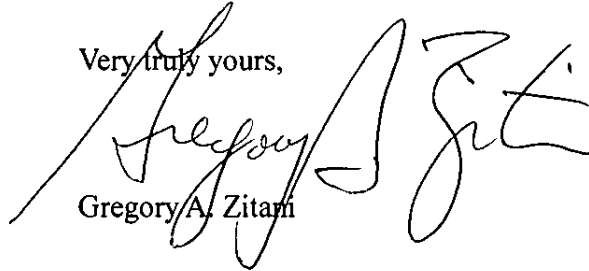

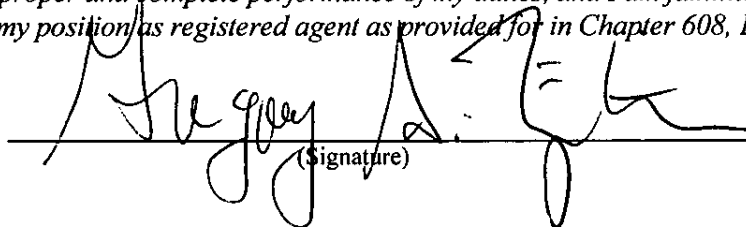

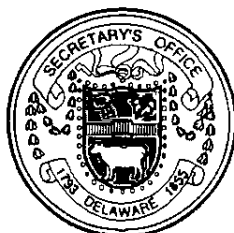
