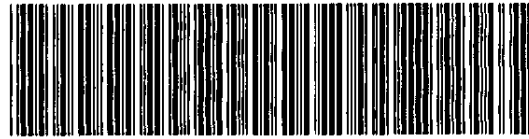

Pursuant to the provisions of Section 617.1002 and 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

The amendments were adopted by the members and the number of votes cast was sufficient for approval. Mr. Jessie Walker, Dr. Gregory Mitchell, Mr. Willie Green, William Carlson approved the minutes.

These Articles of Amendment were adopted by the Board of Directors of said organization at a meeting with a quorum being present which was held on October 28, 2010. This meeting of the directors met the requirements of both the Articles of Incorporation and the by-laws.

AMENDMENTS

The Articles of Incorporation of the **SET FREE COALITION OUTREACH PROGRAMS, INC.** are hereby amended to add the following paragraphs:

1. ~~Area to be served shall include Census Tract 107.02, 303.01, 304.02, 304.02, 308.01~~
2. At least one-third of the governing board shall be composed of residents of low-income neighborhoods, other low-income community residents or elected representatives of low-income neighborhood organizations
3. Set-Free Coalition Outreach Programs, Inc. is free to contract for goods and services from vendor(s) of its own choosing.

1. Article II SECTION 3 \_\_\_ of the Articles of Incorporation is hereby amended to add the following paragraphs:

The purposes of this corporation include: to engage in community development activities (which include housing and economic development activities) which are intended to lead to an improvement of the physical, economic or social environment of it's geographic area of operation by addressing one or more of the critical problems of the area with attention to the needs of persons with low incomes. These activities shall be undertaken primarily, but not exclusively, in the Corporation's geographic area of operation. Nothing in this paragraph shall allow this organization to carry on any activities not permitted to be carried on by an organization exempt from Federal and State income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
