Articles of Incorporation - Addendum Fatherhood Task Force of South Florida, Inc.

ARTICLE VIII - DISSOLUTION OF THE ORGANIZATION

- a. The Fatherhood Task Force of South Florida, Inc. is organized exclusively for Family Enrichment, Educational Research, and Advocacy. Programs, services, and activities may include support from, receipt of, and the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal revenue code, or corresponding section of any future federal tax code.
- b. No part of the net earnings of the organization shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of the organization shall include the distribution of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for political office. Notwithstanding any other provision of this document, the Fatherhood Task Force of South Florida, Inc. shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal revenue code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductable under section 107 (c) (2) of the Internal revenue code, or corresponding section of any future federal tax code.
- c. Upon the dissolution of the Fatherhood Task Force of South Florida, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code; or corresponding section of any future federal tax code; or shall be returned to grantors of grant funds; distributed to the federal government; or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of Miami-Dade County in which the principal office of the organization is then located; exclusively for such purposes; or to such organization or organizations; as said Court shall determine which are organized and operated exclusively for such purposes.

<u>ARTICLE IX – EFFECTIVE DATE</u>

The effective date of the Articles of Incorporation shall be December 18, 2010.
