**ARTICLES OF ORGANIZATION
OF

These Articles of Organization are made for the purpose of organizing a Florida limited liability company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

ARTICLE I - NAME

The name of the limited liability company is Shula Burger, LLC (the "Company").

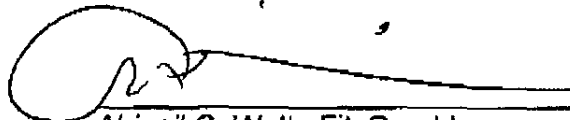
