# ARTICLES OF ORGANIZATION

The undersigned person, acting as the organizer of 39638, LLC, under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

#### ARTICLE I - NAME

The name of this limited liability company is:
