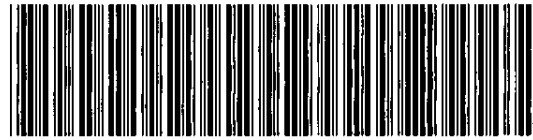


ARTICLE IV

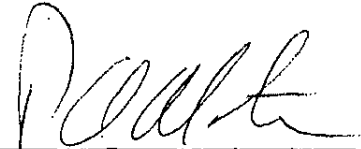
