TO THE

1. The name of this Corporation is **Shadow Communications, Inc.** and the Corporation was originally incorporated on November 1, 2010 pursuant to the FBCA.

2. The Articles of Incorporation of the Corporation, originally filed on November 1, 2010, are hereby amended to delete ARTICLE 1. Name in its entirety and substitute the following in lieu thereof:
