**ARTICLES OF ORGANIZATION OF  
EL BRASITA, LLC  
A FLORIDA LIMITED LIABILITY COMPANY**

The undersigned desiring to form a Limited Liability Company under and pursuant to Section 608.404 of the Limited Liability Act, pursuant to Chapter 608 of the Florida Statutes, of the State of Florida, do hereby certify as follows:

**FIRST:** The name of said Limited Liability Company shall be, EL BRASITA, LLC and the mailing address and the street address of the principal office of the limited liability company shall be 17150 NORTH BAY ROAD, UNIT# 2318, SUNNY ISLES BEACH, FLORIDA 33160, and the street address of the principal office of the limited liability company shall be: 17150 NORTH BAY ROAD, UNIT# 2318, SUNNY ISLES BEACH, FLORIDA 33160,

**SECOND:** EL BRASITA, LLC shall have a perpetual duration from the date of filing of these Articles of Organization.


