**AMENDMENT
TO
ARTICLES OF INCORPORATION
of

Pursuant to the Provisions of Section 617.1006, Florida Statutes, and Article X of its Articles of Incorporation, **ROTARY FOUNDATION OF MIAMI, FLORIDA, INC.**, a Florida not-for-profit corporation (the "Corporation"), as approved by a majority of the Board of Directors of the Rotary Club of Miami, and confirmed by a majority of the members of the Rotary Club of Miami at its regular meeting duly convoked and held on July 7th, 2011, hereby adopts the following amendment to its Articles of Incorporation:

1. Article 1 - Name of the Corporation is hereby amended to read as follows:


ARTICLE I
