1. The name of the corporation (the "Corporation") is **K12-THE KEYPAD REPAIR DEPOT, INC.**

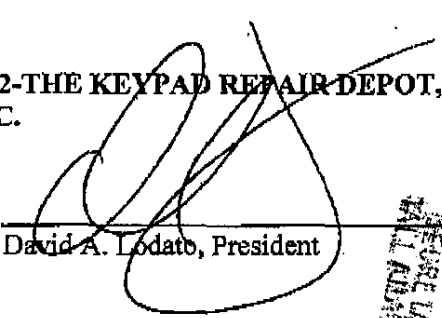
