The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation

**Article I - Name**

**ASSOCIATION OF THAI PROFESSIONALS IN AMERICA AND CANADA, INC.**

**Article II - Address**

**Article III - Purpose**

The corporation is organized as a corporation not-for-profit under the laws of Florida:

1. To promote the advancement of scientific knowledge, technology, and education in Thailand.
2. To establish and promote liaison and cooperation between the association and related organizations in Thailand, the United States, Canada and other countries.
3. To maintain close association and fraternity among Members.
4. To render to Members any assistance deemed appropriate and feasible by the Board of Directors.

The purpose for which the Association of Thai Professionals In America And Canada, Inc. is to organize exclusively charitable, scientific, literary and education within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provision of any future United States Internal Revenue Code.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organization which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose. The distribution of assets upon dissolution is under the operation law of State of Florida.

#### **Article IV – Directors**


