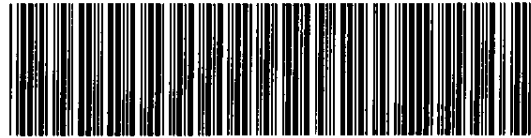

1. Article II is amended to read:

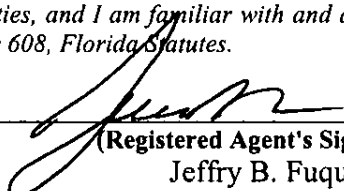

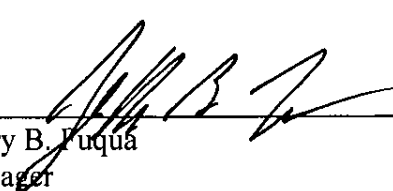

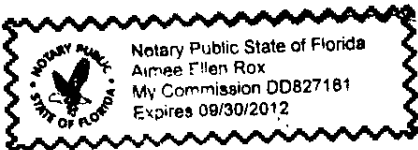
