**ARTICLES OF INCORPORATION
OF
OUTPATIENT ANESTHESIA OF SOUTHWEST FLORIDA, INC.**

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

**ARTICLE 1
NAME AND ADDRESS**

The name of this corporation shall be OUTPATIENT ANESTHESIA OF SOUTHWEST FLORIDA, INC. The initial principal business address of the corporation is 3949 Evans Avenue, Suite 102, Fort Myers, Florida 33901.

**ARTICLE 2
DURATION**

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

**ARTICLE 3
PURPOSE**

The purpose for which the corporation is organized is the transaction of any and all lawful business for which a corporation may be incorporated under the Florida Business Corporation Act, as the same may from time to time be amended.
