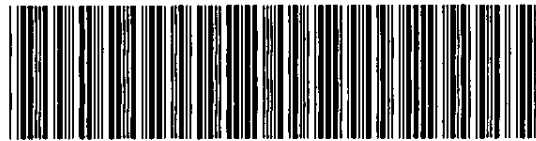

1. **NAME**

The name of the Limited Liability Company is:

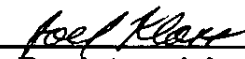
