AGREEMENT AND PLAN OF MERGER

BETWEEN

EVANGELICAL CHRISTIAN HUMANITARIAN OUTREACH FOR CUBA, INC. A Florida Corporation Not-For-Profit

AND

AMERICAS HUMANITARIAN RELIEF LOGISTICS TEAM, INC. A Florida Corporation Not-For-Profit

Pursuant to Section 617,1101, Florida Statutes

A. CORPORATIONS PARTICIPATING IN MERGER.

Evangelical Christian Humanitarian Outreach For Cuba, Inc., a Florida corporation not-for-profit (the "Surviving Corporation") and Americas Humanitarian Relief Logistics Team, Inc., a Florida corporation not-for-profit (the "Disappearing Corporation").

B. NAME OF SURVIVING CORPORATION.

After the Merger, the Surviving Corporation shall continue to have the name "Evangelical Christian Humanitarian Outreach For Cuba, Inc".

The Surviving Corporation shall continue to be incorporated under and governed by the laws of the State of Florida.


