**ARTICLES OF AMENDMENT OF  
THE ARTICLES OF INCORPORATION  
OF  
STEP UP FOR STUDENTS, INC.**

- A. The name of the corporation is Step Up For Students, Inc. (the "Corporation").
- B. The Articles of Incorporation were filed with the Florida Secretary of State on February 18, 2000 under Document Number N00000001090.
- C. Pursuant to the provisions of section 617.1006, Florida Statutes, this Corporation amends paragraph 3, section (b) of Article III of the Articles of Incorporation in its entirety to read as follows:
- “(b) to provide legislatively-authorized K-12 scholarships and related support to give economically disadvantaged families the freedom to choose the best learning options for their children.”
- D. There are no other amendments to the Articles of Incorporation, except as stated above.
- E. The amendment was adopted by the board of directors on October 5, 2011 and no members were entitled to vote on the amendment.
