ARTICLES OF DISSOLUTION

Pursuant to Sections 608.441 and 608.445 of the Florida Limited Liability Company Act, PINECREST SW68 LLC, a Florida limited liability company, does hereby adopt the following Articles of Dissolution:

ARTICLE I

The name of the limited liability company (the "Company") is PINECREST SW68 LLC.

ARTICLE II

The Articles of Organization of the Company were filed with the Florida Department of State on April 5, 2011 and assigned document number L11000041078.

ARTICLE III

The effective date of the Company's dissolution shall be the date of filing of these Articles of Dissolution with the Florida Department of State.

ARTICLE IV

The dissolution of the Company occurred upon the unanimous written consent of the members of the Company dated December 20, 2011 approving such dissolution, as provided in the Company's Operating Agreement and in Section 608.441(1)(c) of the Florida Limited Liability Company Act (the "Act").

ARTICLE V

All debts, obligations and liabilities of the Company have either been paid or discharged, or adequate provision therefor has been made pursuant to Section 608.4421 of the Act.

ARTICLE VI

All remaining property and assets of the limited liability company have been distributed among its members in accordance with their respective rights and interests.

ARTICLE VII

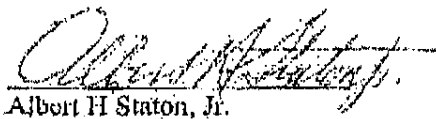

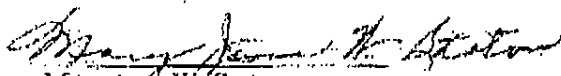
