

Article VIIII

The corporation is organized and operated for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding position of any further United States Internal Revenue law.

- A. Altruism Inc is built on the promise of paying it forward with each of our students. It is our mission to provide educational assistance and cultural exchange by offering opportunities to those less fortunate.
- B. The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future U.S. Internal Revenue law.
- C. No part of the net earnings of Altruism Inc shall be to the benefit of, or be distributed to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of Altruism Inc shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- D. Upon the dissolution of Altruism Inc, the assets of Altruism Inc will be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purposes. Any such assets not disposed of shall be disposed of by the Court of Common Pleas (magistrates court) in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
- E. Altruism Inc, will engage in any other lawful activities whatsoever that are necessary, incident, or convenient to the carrying on of such activities or are intended to promote, directly or indirectly, such interest of the Corporation, and to exercise any and all powers that it might now or hereafter be lawful for the Corporation Code or any act amendatory thereof or supplemental thereto that may now or hereafter be enforce.

Article X

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law or by an organization, contributions to which are deductible under 170(c)(2) of the Internal Revenue Code.
