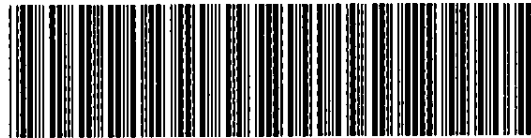

The name of the limited liability company is **Anthony's Coal-Fired Pizza, LLC**.




