ARTICLES OF INCORPORATION OF OCHAB PROPERTIES INC.

ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is Ochab Properties Inc. Its principal office address and mailing address is 5896 Vantage Oak Circle, Delray Beach, Florida 33484

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE
